RECOGNITION

FSD Staff Members were recognized for the following:

Center Elementary School & Principal Amanda Hayes was recognized for being named a U.S. News & World Report Best Elementary School, ranking in the top 40% of all elementary schools in the state of Illinois.

Jena Kleindl teacher at Freeport High School was recognized for being named the 2025 Early Career Educator (less than 5 years of classroom experience) for the State of Illinois by the IL State Board of Education (ISBE).

BLACK HISTORY MONTH

S&P Global Credit Highlights in Connection with Bond Issuances

Freeport School District (FSD) 145 met with bond investors, bond counsel, bond underwriter, and S&P Global to obtain a bond rating on the bond 2025A, 2025B, and 2025C issuance, providing the past and current financial information to bond investors. Upon reviewing the 2024 financial data including audit, budget, economic metrics, gross income, generally accepted accounting principles (GAAP), population, etc., FSD 145 received a bond rating of A.
